How to access the Monash Health Learning system.

### Via a hospital based computer

- 1. Open web browser
- 2. Select "All staff" tab
- 3. Go to "Monash Learning & Training tab Monash Learning & Training
- 4. Select "Go to Full Monash Learning site Go To Full Monash Learning Site
- 5. Login and enter your user name (employee number) and password
- 6. Search for the course (using exact wording listed above), enrol in course and complete as instructed.
- 7. Make sure you pay attention to the completion requirements, some courses require 100% pass rate on the assessments. You will need to repeat assessment until this is achieved to complete requirements.

## Via home based/external computer

- 1. Open web browser
- 2. Go to https://learning.monashhealth.org/
- 3. Login and enter your user name (employee number) and password
- 4. Search for the course (using exact wording listed above), enrol in course and complete as instructed.
- 5. Make sure you pay attention to the completion requirements, some courses require 100% pass rate on the assessments. You will need to repeat assessment until this is achieved to complete requirements.

- 4. Select Employee Self Service Staff Portals
- 5. Select Monash Health Learning
- 6. Login and enter your user name (employee number) and password
- 7. Search for the course (using exact wording listed above), enrol in course and complete as instructed.
